**COVERAGE FOR LOSS AND DAMAGE**

(3) Full Value Protection - This option provides for recovery for lost or damaged items based on current replacement value at the time of loss or damage, up to the total dollar amount of valuation declared by shipper. You may be charged for coverage provided under this option.

Shipper represents that it has not provided E Movers any food, medicine, medical devices, items to treat or assist a disabled person, or items used for care of a minor child in the shipment. Shipper disclaims any right to assert the aforementioned items are being shipped with E Movers and will not demand any such release of said items from E Movers at any time of the move.
